### **Best and worst case scenarios of the Warrantholders' investment in the Put Warrants:**

- **Best case scenario**

The level of the HSI decreases substantially resulting in a significant increase in the price of the Put Warrants. If the Warrantholders hold the Put Warrants until the Expiry Date, the higher the Exercise Level of the Put Warrants is relative to the Closing Level of the HSI, the higher the return will be after considering the transaction costs. ### **2.1 No investigation or review performed on the HSI and HSICL**

We have not performed any investigation or review of the HSI or HSICL. Therefore, you should not assume that the issuance of Put Warrants over HSI represents a recommendation by us of an investment related to the HSI.

In addition, you should be aware that HSICL or the companies constituting the HSI has not participated in the preparation of the Base Prospectus, the First Supplementary Base Prospectus and this Term Sheet, or in establishing the Terms. As a consequence, there can be no assurance that all events occurring before the date of this Term Sheet that would affect the level of the HSI or the share price of the companies constituting the HSI (and therefore the price of the Put Warrants) have been publicly disclosed. Subsequent disclosure of any such events or the disclosure of or failure to disclose material future events concerning the HSI or the companies constituting the HSI could affect the level of the HSI and therefore the trading price of the Put Warrants. Further, neither HSICL nor the companies constituting the HSI has any obligation with respect to the settlement amount to be paid to you (if any) upon exercise of the Put Warrants, including any obligation to take into account, for any reason, our needs, or your needs.

### **2.2 Credit Risk**

If you purchase our Put Warrants, you should be aware that you will be relying on the creditworthiness of our Company. You must therefore make your own assessment on the credit risk associated with KIBB and our ability to perform our obligations in respect of our Put Warrants. Credit ratings assigned by the rating agency reflect their opinion on our credit risk, which is only one aspect of any investment decision, and ratings are subject to change.

### **2.3 Value of Put Warrants may be affected by Inherent risks relating to the HSI**

As one of the earliest stock market indexes in Hong Kong, the HSI was publicly launched on 24 November 1969. The HSI has become the most widely quoted indicator of the performance of the Hong Kong stock market.

In order to better measure the performance of the major sectors of the market, HSI constituent stocks are grouped into Finance, Utilities, Properties, and Commerce and Industry sub-indexes.

You should note that the occurrence of any material or adverse events in relation to the companies constituting the HSI may affect the performance of the HSI and may consequentially affect the value of Put Warrants.

### **2.4 Time decay**

Put Warrants have expiry dates and therefore, a limited life. Put Warrants are generally more valuable when the remaining life of the Put Warrants are longer. After expiry, the Put Warrants will cease to be traded and can no longer be exercised, hence will cease to have any value.

### **2.5 The Base Prospectus, the First Supplementary Base Prospectus and this Term Sheet are not the sole basis for making an investment decision**

The Base Prospectus, the First Supplementary Base Prospectus and this Term Sheet do not take into account your investment objectives, financial situation or particular needs. Nothing in the Base Prospectus or the First Supplementary Base Prospectus or this Term Sheet should be construed as a recommendation by us or our affiliates to invest in the Put Warrants or the HSI.

### **2.6 Adjustment related risks**

The occurrence of certain events (including modification and cessation of calculation of the HSI and replacement of HSICL by a successor) may entitle us to adjust the Terms of the Put Warrants. However, we are not obliged to adjust the Terms of the Put Warrants for every event that affects the HSI. Any adjustment or decision not to make any adjustment may adversely affect the value of the Put Warrants.

### **2.7 Calculation Methodology**

The HSI adopts free float-adjusted market capitalisation weighted methodology with a pre-determined cap on individual constituent securities.

### **2.8 Exchange rate risk**

The conversion may potentially result in foreign exchange losses if there is any adverse movement in the exchange rate which will be borne by the Warrantheolders.

### **2.9 Risks related to any possible future outbreaks of disease**

Any possible future outbreaks of disease may have a material and adverse effect on the performance of HSI and consequently affect the value of the Put Warrants.

Should there be another outbreak of disease that causes disruptions to global and domestic economic activity, KIBB Group's financial position may be adversely impacted. Prolonged and material impact on KIBB Group's financial position may also cause a downward rating in KIBB Group credit rating profile, which could in turn affect the ability to meet our financial commitments as a Structured Warrants issuer.

KIBB Group has put in place the necessary Standard Operating Procedures ("SOP") for the possible future outbreaks of disease and fortify the vibrancy of Business Continuity Management ("BCM") of the Group to ensure the preparedness, responsiveness and robustness in managing this event risk.

#### 3.1 Basis of arriving at the issue price

The issue price of the Put Warrants of RM0.540 was based on an option pricing model which takes into account the Exercise Level of the Put Warrants, volatility of HSI, tenure of the Put Warrants and interest rates.

#### 3.2 Details on use of gross proceeds

We will use the indicative total gross proceeds arising from the Offer of up to RM54.00 million, based on the issue price of RM0.540, in the following manner:-

#### **3.4 Further Issue**

The Deed Poll allows KIBB to create and issue further Structured Warrants in respect of the same series of Structured Warrants pursuant to the Base Prospectus and the First Supplementary Base Prospectus ("**Further Issue**") without the consent or sanction of the existing Warrantholders. The Further Issue will form part of the existing Structured Warrants in issue ("**Existing Issue**").

For the purpose of facilitating Market Making, KIBB may apply for a Further Issue in respect of the Structured Warrants subject to the following conditions:

- (i) the Further Issue is for the purpose of facilitating Market Making;
- (ii) the terms and conditions of the Existing Issue either permit the Further Issue or have been properly amended to give us the right to issue and list one or more Further Issues;
- (iii) the terms and conditions of the Further Issue and the Existing Issue must be identical except for the size and tenure of the issue; and
- (iv) the Issuer holds not more than 50% of the Existing Issue at the time of application for the Further Issue.

#### **3.5 Liquidity Provision**

We will be acting as the liquidity provider for the trading of the Put Warrants on Bursa Securities.

As an Issuer, it is our business policy to stand by our products by providing liquidity. As stipulated by Bursa Securities, we will maintain a minimum market presence of 80% of trading hours on each day that Bursa Securities is open for trading and a maximum spread between bid and offer prices of ten (10) bids.

The process of providing liquidity involves maintaining bid and offer prices on the trading system of Bursa Securities on each Market Day, over the life of the Put Warrants. Although we endeavour to provide liquidity for the Put Warrants on Bursa Securities, the level of liquidity will depend on competitive forces and the price at which the Put Warrants will trade on Bursa Securities upon or subsequent to its listing. Besides the supply and demand for the Put Warrants in the secondary market, there are other factors affecting the price of the Put Warrants such as, without limitation, the underlying unit price, intrinsic value, dividend expectations, expected volatility, prevailing interest rates and the time left to the expiry of the Put Warrants.

As the liquidity provider, we would need to maintain a certain number of Put Warrants as inventory for the purposes of liquidity provision during the tenure of the Put Warrants. The minimum quantity of Put Warrants for which liquidity will be provided is fifty (50) board lots (5,000 units of Put Warrants). We may during the tenure of the Base Prospectus and the First Supplementary Base Prospectus issue additional Put Warrants in a particular series subject to the approval of Bursa Securities.

However, you should note that there would be circumstances under which we are unable and could not be obliged to provide liquidity, due to reasons beyond our control. Such circumstances are set out in Section 5.2 of the Base Prospectus.
